One major goal of this project is to develop (in collaboration with Haipeng Shen of Statistics Department UNC-CH) statistical methods addressing multiple testing, one of the most difficult issues in similar types of analysis. Another main goal is to investigate (in collaboration with Moshe Szyf of McGill) the feasibility of saliva DNA in methylation analysis in large-scale social science studies.

The Illumina GoldenGate array targeted 1,536 SNPs. A total of 1,140 SNPs in 130 genes were successfully genotyped. The majority of the genes are associated with aggression identified in transgenic or knock-out studies of mice, or previously found to be related to risky behavior.
